7. The Society shall shift the present existing within two years from the date of handing over possession of the plot.
8. The D.D.A. reserves its right to alter any term & conditions on its discretion.
9. The land shall be used by the Society for the construction of Nursery/Sr. Sec./Middle school for no other purpose whatsoever. No residence is permitted except a small hut for chowkider.
10. The building plans should be got approved from local body/JDA before undertaking any construction of land.
11. The Society shall complete the construction of school building on the land within a period of years from the date of handing over possession of land.
12. The land shall not be transferred/sub-leased to any other organization/Dept. by the Society without prior permission of the DDA obtained in writing.
13. The perpetual lease shall be executed by the lessees at their own cost, as and when called upon to do so.
14. The Society shall provide fencing and boundary immediately after taking over the possession to prevent the encroachment.
15. No person attending the school shall be required to take part in any religious/Institution or to attend any religious worship without his/her consent and no citizen shall be deprived of admission in school on ground of religion, race, caste, language or any of them.
16. In the event of de-recognition of school by the Director of Education, Delhi Admin. or any other Competent Authority, the lessees shall be required to pay premium for the land allotted at the market rate prevailing on the date of de-recognition of the school or the land with super structure, fittings etc. shall revert to the Govt. on payment of compensation as may be decided by the Govt.
17. The school shall not increase the rates of tuition fees without the prior sanction of the Director of Education, Delhi Admin. and shall follow the norms of Delhi School Education Act/Rules, 1973 and all instructions issued from time to time.
18. The Vaish Aggarwal Educational Society shall provide the content of free education as laid down under rules by the government, from time to time is strictly complied with giving admission to the students belonging weaker sections to the extent of 25% and grant scholarship to them.
19. The Director, will have two nominees on the Board.


