Sub:- Issue of Revised Essentiality Certificate for Sr. Sec. School from class Ist. to XII under rule 44 of Delhi School Education Act, 1973.

Sir,

With reference to your application dated 13.12.99 on the subject cited above, I am directed to convey the permission of the Director of Education, Delhi to your Society to establish a new school from class Ist. to XII (without Aid) in zone XI, Dist. North/West-B with effect from 1999-2000 in place of E.C. already issued from Zone-III vide No zone-III(north)/Rec./272 dated 27.3.90. Essentiality Certificate already issued to the Society on 27.3.90 was valid for Ist. to VIII class w.e.f. the session 1990-91 subject to the following terms and conditions:-

1. That the provision of DSER 1973 and rules framed there under shall be observed by the society.
2. That the management of the school will get the scheme of management approved from the department immediately.
3. That the management of the school will not ask for grant-in-aid from the department.
4. That the school will not run for the profit of any individual, association or group of persons.
5. That the management of the school will apply for grant of recognition of the school under DSER 1973 and recognition will not be granted unless statutory provisions provisions of section 4(1) (a) to (f) read with rules 50 and 51 are fulfilled.
6. That the school shall be run under the control of the Vaish Aggarwal Educational Society and suitable funds will be made available. All the construction of suitable building on the land allotted to the society as declared as per the specifications of the department with in a period of three years.
7. That the management of the school will obtain land from D.D.A. in the name of the society through Directorate of Education, Delhi and shall construct a school as per specification of the deptt.

3. That the adequate and sufficient accommodation of 12 sq. ft. per student shall be provided for class room. The normal size of class room will be 24' x 20'. No other activities other than educational shall be run.
 2. If the recognition for the proposed school is not sought after fulfilling all the above conditions, within a period of three years, the permission to run new school shall be treated as cancelled.
